Did you know? According to the Military Child Education Coalition, about 700,000 children in the US today have at least one parent deployed.

Did you know? As of September 30, 2008, there were almost 1 million veterans of Operation Iraqi Freedom and Operation Enduring Freedom.

The transition from civilian life to military service and back again is both a physical and emotional journey for service members and families.



The TRICARE Young Adult program extends dependent medical coverage via a premium-based program. Coverage is extended from age 21 (age 23 if full-time college student and dependent on sponsor for more than 50 percent of your financial support) up to age 26 for unmarried dependents who don't have access to employer-sponsored health care coverage.

The TRICARE Young Adult program will be implemented on May 1, 2011. Coverage can be retroactive to January 1, 2011 if monthly premiums are paid back to January 1st or a later date if the person's eligibility became effective subsequent to January. At implementation, TRICARE Young Adult will offer TRICARE Standard/Extra coverage with the applicable co-pays and deductibles. The catastrophic cap for TYA enrollees will be combined with the sponsor's family cap for a total as applicable for their TRICARE status.

Care for TRICARE Young Adult beneficiaries at military treatment facilities will be available on a spaceavailable basis. Enrollees will also have access to military pharmacies. In the future (currently scheduled to begin October 1, 2011), there will be a TRICARE Prime-like option under the TRICARE Young Adult program.

#### Eligibility

- TYA beneficiaries must have a sponsor who is currently TRICARE-eligible (and enrolled in TRICARE Reserve Select or TRICARE Retired Reserve, if applicable).
- TYA beneficiaries must have previously lost (aged out of) TRICARE coverage and not yet age 26.
- TYA beneficiaries must be unmarried.
- TYA beneficiaries must not be eligible for employer-sponsored health coverage.
  - May be eligible for student or similar health coverage. With other health insurance, TRICARE would be the secondary payer.
- TYA beneficiaries cannot be members of the uniformed services.
- TYA beneficiaries may lose and regain eligibility.
- Eligibility for TRICARE Young Adult is recorded in DEERS. Anyone who does not show as eligible in DEERS or has questions or concerns about eligibility should be directed to a RAPIDS (DEERS) site for assistance. Anyone not showing as eligible in DEERS may not be enrolled.
- TRICARE Young Adult coverage includes TRICARE Pharmacy benefits.
- TRICARE Young Adult coverage does not include dental coverage. Eligibility for the TRICARE Dental Program and the TRICARE Retiree Dental Program will end when the dependent turns age 21 (or 23 if a full-time student) or as specifically indicated in those dental programs.

#### Enrollment

- Because the enrollment form was released late, TRICARE has extended the deadline for TRICARE Young Adult enrollments requesting a May 1 start date. Beneficiaries who submit their enrollment form and premium payment so that it is received or postmarked on or before May 31<sup>st</sup> can request a May 1 (or earlier if requesting retroactive coverage) effective date.
- Eligible beneficiaries can enroll into TRICARE Young Adult using the *TRICARE Young Adult Application* available on <u>www.triwest.com</u>, on <u>www.tricare.mil</u>, and through Beneficiary Web Enrollment (<u>www.tricare.mil/bwe</u>).

#### Monthly Premiums

- A 3-month premium payment is due with the enrollment form plus premiums for each month beginning in January (or a subsequent month if eligibility was established at a later date) if retroactive coverage is desired. Any retroactive coverage must be requested with the initial enrollment. Retroactive coverage will only be permitted to January or the subsequent month during which eligibility was established. No other variations of retroactive coverage will be permitted. Retroactive coverage may not be requested at a date following initial enrollment.
- TRICARE Young Adult coverage requires paying a monthly premium. Monthly payments by automatic recurring electronic payment (credit, debit or electronic funds transfer) are required. Premiums may not be paid via allotment from the sponsor's active duty or retired pay.

# Mrs. Mullen: Military Children Deserve Respect, Support

Military children need and deserve the nation's utmost respect and support as they continue to weather a decade of war, the wife of the nation's top military officer said in Washington in late March. "I do not believe, and have not believed for quite some time, that there are many issues more important to the future of our armed forces indeed to the future of our country — than those confronting military children today." said Deborah Mullen, wife of Navy Adm. Mike Mullen, chairman of the Joint chiefs of Staff.

It's evident that some of the stress on military children is manifesting itself in the classroom as poor grades, inattention, aggression and even overachievement, Mullen said. To some degree, she added, all can be signs of a child under duress and in need of support. "The classroom can be and should be a haven of learning and growth and development," she said. "I ask only that it can also be a place where military children can find the acceptance they need and the respect and understanding they so richly deserve." To better support military children, Americans must begin to bridge the ever-growing military-civilian divide, she noted.

The reality is fewer than 1 percent of the nation's population serves in the military, she said. Still, Americans must keep service members and their families at the forefront. "When America no longer knows her troops, she can do little in all practicality to support them in the way they need it most," Mullen said. "We aren't at that point yet, of course, and I hope we don't ever get there." "Ironically, it would be their toughness — that resilience of which they are so proud — that may hasten, if not ensure, their anonymity, so fearful they have become in asking for help," she said.

special kind of fear they labor under. These children don't know if their mom or dad will survive the day, and they face this fear over prolonged periods of time. And, unlike children of police officers or firefighters, it's a fear that isn't relieved at night when their parent walks in the door. Their parent won't walk through the door for months at a time. And when he does, it's a pretty safe bet he won't be quite the same guy as when he left" she said noting that the returning parent may also have emotional challenges. Mullen asked the audience to imagine a life with the added worry of receiving a knock on the door with the worst news imaginable. "and no one on either side of the classroom, let alone the neighborhood, understands." "These are the challenges I ask you to consider," she told the audience. "These are the problems I ask you to solve, and the shoes I ask you to walk in, if only for a few days."

### **2011 Armed Forces Salute Military Tickets**

Walt Disney World has just announced that Active and Retired U.S. Military, including members of the U.S. Coast Guard and members of the National Guard

or Reservists, may purchase 4-Day Walt Disney World Armed Forces Salute Tickets for themselves and up to five (5) family members and/or friends from \$138 each. That is a maximum total of 6 tickets that can be purchased by each military member. All tickets and options are non-transferable and must be activated and purchased by September 28, 2011. Black out dates exist for these tickets. They may not be used at all between December 17 - 31, 2010, April 17 - 23, 2011 at all Disney World theme parks, and July 4, 2011 at Magic Kingdom only.

Vouchers are available for purchase at Shades of Green and on military bases tax free. You must then take the voucher to a WDW ticket window and exchange for a ticket. Tickets are also available for purchase at Disney World ticket windows, but this purchase will be taxed.
