# Bulldogs help Minnesota Biathlon Team win national championships

The Minnesota National Guard Biathlon Team won First Place Team overall at the 2009 Chief National Guard Bureau Biathlon Championships. Three races took place at Ethan Allen Firing Range in Jericho, Vt. Mar. 1-7, 2009. Minnesota earned First Place overall for finishing First Place in the 15 kilometer Patrol Race. The race was a nail-biter with Minnesota narrowly defeating the Vermont National Guard team in 50 minutes and 41 seconds with strong shooting at the range and a hard-fought team effort on the ski trails. The members of the Patrol Race team were Maj. Paul Peterson (Army), Capt. Eric Nordgren (Air), Master Sgt. Greg Wohlfeil (Air), and Tech. Sgt. Nicholas Gray (Air). The South Dakota National Guard Team came in 3rd. The relay race on the last day of competition was cancelled due to warming temperatures and deteriorating trail conditions.

“The team’s performance on the range was stellar,” said their coach Chief Warrant Officer Roger Sorben. “Eric hit the target on his first shot, Nick knocked his target down on the first shot with a bullet that split when it hit the edge of the target, and Greg collected himself after his first shot was a miss and knocked his target down with a solid shot.”

In the individual races earlier in the week of competition, Capt. Eric Nordgren finished 9th in the 10k Sprint competition and 12th in the

20k Individual. Nordgren narrowly missed selection to the All Guard Biathlon Team, which is based on these performances. Lt. Col. Eric Chandler finished 30th in the 10k Sprint and 24th in the 20k Individual. He was awarded a silver medal for 2nd place among the 18 novice competitors in the field of 60 biathletes.

# 179th Fighter Squadron wins Raytheon Trophy

The Chief of Staff of the Air Force, Gen. Norton Schwartz, recently announced that the 179th Fighter Squadron is the recipient of the 2008 Raytheon Trophy for its accomplishments in Fiscal Year 2008.

The Raytheon Trophy, formerly known as the Hughes Trophy, is awarded for outstanding performance to an Air Force or Air National Guard fighter unit with a mission in air defense or air superiority. Units are judged on performance in the air defense or air superiority mission, exercise participation, inspection results, and squadron and/or individual accomplishments.

Accomplishments from this rating period include the following:

- Operation Noble Eagle deployments to Hickam Air Force

Base, Elmendorf Air Force Base and Minneapolis in support of the Republican National Convention – flying a total of 264 sorties

- The Wing’s third deployment to Joint Base Balad, Iraq

- The 2007 Operational Readiness Inspection “Excellent” rating

- The 2008 Alert Force Evaluation “Mission Ready” rating

- Earning OSHA’s Voluntary Protection Program Star rating

This is only the fourth time an Air National Guard unit has received the award and only the second time an F-16 unit has received the award since its inception in 1953. 179th Fighter Squadron Commander, Lt. Col. Eric Chandler said, “It’s awesome for the Bulldogs to get recognition for the hard work they did in 2008. All our people make it look easy, but

it isn’t. They deserve this kind of award.”

Wing Commander, Col. Frank Stokes stated that “This award is especially important to our Wing because it validates the intense effort we have put forth over the last several years: the many times we have answered calls from ANG, ACC, and the Air Force; packed up and deployed on short notice; and accomplished the mission in a professional, efficient manner. We have answered those calls repeatedly, and often returned to take an inspection or deploy to the AEF, and then immediately fulfilled another short notice request. We have done all this without complaining, and in a manner that often left the operation in better shape than when we came. The Bulldogs should feel good that our efforts were not lost on our nation’s leadership, they have now rewarded us for them.”

The Raytheon Trophy will be presented at a later date. No details on the event are yet available.

## Bulldog named Duluth Firefighter of the Year

A 148th Fighter Wing Firefighter has been named the Kiwanis Club of Duluth Firefighter of the Year.

Tech. Sgt. Charles Smith, an 11-year veteran of the Duluth fire department and member of the 148th Fighter Wing received the award which is presented to a firefighter

# Command of 148th Fighter Wing changes hands

Duluth's 148th Fighter Wing has a new commander. Col. Frank H. Stokes took command of the 148th Fighter Wing during an official change of command ceremony Mar. 22, 2009 at the Duluth Air National Guard base.

Stokes took command from Col. Mark R. Johnson who will transfer to Minnesota's Joint Force Headquarters in Saint Paul. Johnson has been the base commander since July of 2004.

The new wing commander told guard members they've reached the top and are now riding the wave, "Bulldogs, It is now our job and your job to instill that reputation in this wing. I want you to smother your Airmen with it. Infect your co workers with it. I want you to make it a part of your daily life."

Stokes is a Duluth native who joined the Air Force in 1983 and later joined the 148th Fighter Wing in 1991. He has served in various positions at the 148th to include Air Operations Officer, 179th Fighter

Squadron Commander, Maintenance Group Commander and, most recently, Vice Commander. Additionally, Stokes served as the 455th Expeditionary Maintenance Group Commander at Bagram Airfield, Afghanistan from January to May 2007 where he earned the Bronze Star. He is a command pilot with over 3,300 flying hours, of which 1,260 are as an instructor pilot in the F-15 and F-16.

"I promise I will do everything in my power to guide the Wing toward future success. As I told you a few weeks ago, no one will work harder-- with more dedication or enthusiasm-- than I," Stokes said.

Stokes holds a master's degree in aerospace engineering and mechanics from the University of Minnesota. He is a graduate of Leadership Duluth through the Duluth Area Chamber of Commerce, has served on the board at Kenwood Lutheran Church and coached baseball for the Central Little League. He and his wife, Kristy, have four sons. During the

ceremony, he thanked his family for all of their support over the years and making the best of the time that he has been away.

Both Stokes and Johnson placed all the credit for the success of the 148th on the brave men and women who have served over the years.

“I joined this unit because I loved to fly. But during that 28.5 year time period, something changed, something happened,” Johnson said. “Instead of filling the void of flying, all the people in this wing have filled my heart.”

The 148th Fighter Wing has had three tours in Iraq over the last four years and has been praised for their other assignments when called upon since Sep. 11, 2001.

to the elements in the civil engineering yard. Once he had determined that the generator was a necessary component for the oxygen charging system, he cleaned and repaired the damage it had received due to exposure to the weather. He procured a concrete building to house the unit, and his actions saved the USAF \$40,000.

Dwyer feels that the most important accomplishment of his tour

was when he rescued an Airman from the pool. He was alerted to the fact that an Airman had become exhausted and was at the bottom of the pool. Dwyer immediately took action, and while fully clothed, rescued the drowning Airman. After performing the rescue, he removed the Airman from the pool, opened his airway, and had the Airman transported by ambulance to the hospital. He was happy to see when he followed up on the Airman that he had fully recovered.

When asked what makes for a good deployment, Dwyer said, "What makes for a good deployment is, above all, a positive attitude. As it states in the Air Force

Core Values, Integrity First, Service Before Self, and Excellence in All we do. Its not about me, it's about how I can help. I think it is each of our duty to pass on the knowledge we have gained. As the saying goes, make your days count; don't count your days."

Please welcome Tech. Sgt. Dwyer back from his tour of duty. He has done us proud.

## *The New World of Self-Care*

Just as our everyday lives are transitioning to a world of self care in banking, education, and appointment scheduling, the military is also taking advantage of the benefits of the electronic age. The new "virtual" world has already changed the way we do business. Along with this new virtual world, our Wing has seen dramatic increases in the number and frequency of deployments as well longer tour lengths. All things considered, it has become difficult for people to find the time to come to the Military Personnel Flight (MPF) in person to check on their records. However, this new virtual world will soon make your military personnel record available to you 24 hours a day/7 days a week.

Many of you have heard of vPC-GR (virtual Personnel Center – Guard/Reserve). Most of you have your accounts and passwords set up to access this new site. If you have not done this, now would be a good time to do so. vPC-GR is a stepping stone which will bring us into the new Defense Integrated Military Human Resource System (DIMHRS) expected to come on-line in 2010. The Air Reserve Personnel Center (ARPC) has pulled one full time position from every MPF across the nation (ours was taken in March of 2008) and used that work year to start up a contact center in Denver, CO to manage the vPC-GR. This contact center now acts as the central system for

many of the actions once handled by MPF personnel. vPC-GR and the ARPC contact center are the focal points for your duty history, awards & decorations, correction of military records, EPRs & OPRs, and document requests. You will even apply for your retirement on line! This list is expected to grow.

You will be affected by these changes more personally beginning in July of 2009. The MPF is currently auditing the hard copy of your military personnel record to make sure everything is in order. In July, we will be packing up the records and mailing them to Denver as we transition to electronic personnel records. Once the records are shipped, you will be able to access your record through the Virtual MPF site in the Automated Records Management System (ARMS). The MPF will no longer maintain hard copies. You'll be able to access copies of all your documents and monitor your military career electronically.

As always, the MPF will be here to help you with the transition. We are learning new processes right along with you. The ARPC contact center number at Denver is 1-800-525-0102, or if you are currently a military member you can log on 24 hours a day/7 days a week at [arpc.afrc.af.mil/vPC-GR/](http://arpc.afrc.af.mil/vPC-GR/). Retirees with questions on pay, survivor benefits, or address changes can also utilize the contact center number listed above. Your local MPF customer service number is 218-788-7212.

This border city across from San Diego is winding up a violent year with at least 843 killings in 2008, a Mexican official said Tuesday, Dec. 30, 2008.

56 per 100,000 is still below that of the deadliest U.S. city New Orleans, which had about 95 killings per 100,000 inhabitants in 2007.

Officials estimate that more than 5,300 people died across Mexico in organized crime-related slayings in the first 11 months of 2008.

photo shoot on the blustery tarmac, everyone went inside to the Operations building for a small celebration.


